ARTICLE - 3


Objectives of the Organization

5. To develop, organize and carry out activities which will promote Social, Educational and Economic Development of women, children and youth.



Finance / Source of funds.



The Second Party Shri. C. Jayan is appointed as the VICE CHAIRMAN of the TRUST.



The Third party Shri.N.Sudarsanan is appointed as the TREASURER of the TRUST.




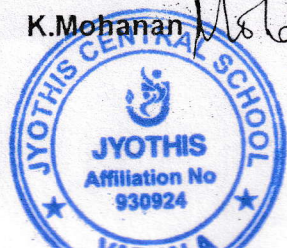
The period of the members of the Executive committee, shall normally be THREE / FIVE years or until the appointment of new members from among the members of the Board of Trustees.

The existing office bearers are also eligible for reappointment.

Any member of the TRUST may resign by giving one calendar month notice in writing to the **CHAIRMAN** of the TRUST, Showing his intention to do so, and on the expiration of the notice period he shall cease to be a member by the shall nevertheless continue to be liable to the TRUST for any amounts due to him to / by the TRUST.

Any Trustee or Trustees who act or do anything detrimental to the interest of the TRUST may be dismissed by the Board of Trustees at a meeting of the Trustees specially convened for this purpose and by resolution approved by the majority of the total members of the TRUST present in the meeting after giving him / them one month notice and giving opportunity to explain his / their stand.

#### ARTICLE - 6

##### Quorum

1. The QUORUM for the meeting of the Board of Trustees and the Executive committee shall ordinarily be 6 and 3 respectively. But the quorum for the meeting of the Board of Trustees when a Non - Confidence motion is to be considered shall be 5 And 2.
2. In case a meeting of the Executive Committee or board of Trustees could not be conducted for want of quorum, the same shall be postponed to another date the number of members actually present on that postponed date shall be considered and shall convene the meeting. In the postponed meeting no item other than that in the original agenda shall be taken for consideration.
3. Normally the meeting of the Executive committee or Board of Trustees shall be chaired by the Chairman of the TRUST. In his absence Vice Chairman or any other member who is present for the meeting shall be elected to the chair for the particular meeting.

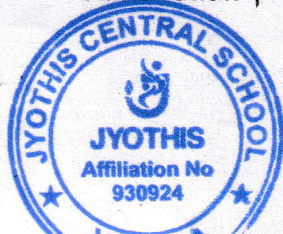

**ARTICLE - 7**

Powers and Duties of Executive Committee of the TRUST

- 8. To apply and avail registrations / licenses / permits / approvals / tax exemptions / reliefs to be availed from the state / central governments / organizations / Education Bodies .
- 9. Executing the day-to-day business / operation / activities of the TRUST like proper running of the institution, appointment / suspension / dismissals of the employees of the institutes of the TRUST.
- 10. Board of Trustees has the power to constitute sub committees for specific purposes with not less than 3 members from the Board of Trustees and one expert in the concerned field. The recommendations / views of this specialist sub committees shall be implemented only after the approval and modifications, if any of the executive committee of the trust.
- 11. To represent the TRUST in any legal matters and to appoint legal advisors / advocates to represent the TRUST in the court of justice.
- 12. To prepare and maintain the books of accounts, to appoint auditors to prepare and finalize the Financial statements ending March 31<sup>st</sup> of every year and to get audited with the auditors of the TRUST and approval of the annual general meeting.
- 13. To open and operate bank accounts of TRUST in the name of the TRUST which shall be operated by the treasurer along with the CHAIRMAN of the TRUST.
- 14. To apply and avail any loan / financial assistance in the name of the TRUST / for the purpose of the TRUST, from any nationalized or scheduled Banks or any financial

institutions or state or central governments or from any voluntary organizations within or outside the country, hypothecating the immovable / movable property of the trust and or additional collateral securities as to the norms and regulations of the financial institutions and repay the loans with interest in due dates.

- 15. To maintain proper Minutes Books of all the meetings of the Board of Trustees / the executive committee / sub committees of the TRUST / Annual Meeting of the Board of Trustees. (Separate Minutes Book should be Maintained for those Committees)
- 16. The Executive Committee of The Trust shall carry on complete management of all the affairs of the institutions of the TRUST without prejudice to the above said general powers. The managing trustee shall have powers to purchase or acquire or to receive by way of gifts and / or to take lands, buildings or other constructions on lease.
- 17. The Executive Committee of The Trust has authority to levy such fees from the tenants and deal with proceeds as they may think proper. All such expenditure relating to institutions under the TRUST like lease rent, salary, wages, allowances, interest on loans and other day-to-day administrative and managerial expenses shall be met from the proceeds of the institutions of the TRUST or from other sources approved by the Executive committee from time to time.
- 18. To institute, conduct, defend, compound with others, compromise adjust, refer to arbitration or abandon any legal or other proceedings, claims, or disputes by or against the TRUST and to authorize by resolution one or more of the Trustees for the purpose.
- 19. To insure and keep insured all or any of the buildings and other assets of the TRUST.
- 20. To invest the surplus funds of the TRUST in securities or in such manner as they may think fit and proper in the interest of the TRUST.

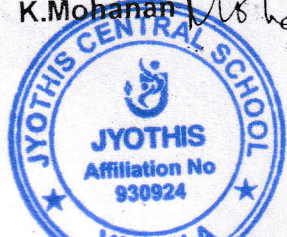

Winding up


